### 1% "SET-ASIDE"

- 1% of its Title I, Part A allocation for Parent and Family Engagement (\$165,000). Campus:

# WHAT IS A TITLE I SCHOOL?

Schools with a 40% or higher of economically disadvantaged students Escuelas con el 40% o mas de estudiantes con desventaja económica.
